(after 2 Hrs.) <b>\$200.</b> Per ½ Hr. <b>Christmas eve., \$250.</b> Per ½ Hr. <b>Christmas morning.</b>
<b>11.</b> The Purchaser agrees to be responsible for harm, loss, or damage of any kind to performer's person or property due to negligence while located at the place of performance (Section 3 herein).
<b>12.</b> The person signing for Purchaser agrees to be personally, jointly and severally liable for the terms of this contract.
<b>13.</b> No performance at the engagement will be recorded, reproduced, or <u>transmitted</u> from the place of performance in any manner whatsoever <u>without a specific written agreement</u> from the performer.
<b>14.</b> Performer agrees that photographs taken by <u>purchaser's</u> service, customers or <u>client's</u> do not require any special agreement or permission. Any commercial or advertisement or informational brochure used with performer's image or photo will require <u>written permission</u> and a fee may be required to use performers image.
<b>15.</b> Performer has permission to photograph himself for personal portfolio and provide information to any purchaser client or guest who wishes a referral. Said information to be approved by purchaser.
<b>16.</b> Any Attached riders or documents pertaining to this performance are herein made a part of this contract.
